


Q1 In which state do you teach?





Q5 How many students are involved in your extracurricular theatre program?







Q7 In theatre classes are offered at your school, how many students are enrolled in them as of the current semester?





Q8 How many productions does your school produce each year?



Q9 What is the average size of your audience for each production?







Q11 What is your annual theatre production budget (what does your district provide)?









Q15 What do you feel is the level of support for theatre education in your school?







Q17 What do you feel is the level of support for arts education in your state?





Q18 What is your level of understanding of how arts education is included in the federal education law, the Every Student Succeeds Act?





Q19 Are there education policies, legislation, or regulations in your state that you feel hinder your program's success?







Q21 How often do you use the advocacy resources provided in schooltheatre.org?







Q23 What kind of advocacy-related workshops do you think would be most useful at state and national EdTA events? Check all that appply.









Q27 How many CTE certified educators are there in your school?


